VIA MAIL TO ALL KNOWN CREDITORS

Re: In the Matter of the Bankruptcy of Big Rig Partz Inc.

As you may be aware, on July 5th, 2024, on application by Royal Bank of Canada, the Supreme Court of British Columbia pronounced an Order (the “**Receivership Order**”) appointing Grant Thornton Limited (“**GTL**”) as the receiver (in such capacities, the “**Receiver**”) of all the assets, undertakings, and property of Big Rig Trailers & Leasing Inc., Big Rig Tires & Services Inc., and Big Rig Partz Inc. (“**BR Partz**”).

Please be advised that, pursuant to the powers granted in an amended and restated Receivership Order pronounced on August 19, 2024, the Receiver filed an assignment in bankruptcy for BR Partz pursuant to Section 49 of the Bankruptcy and Insolvency Act, R.S.C. 1985, c. B-3, as amended (the “**BIA**”) whereby Grant Thornton Limited was appointed as the trustee in bankruptcy (in such capacities, the “**Trustee**”) over the estate of the BR Partz.

Enclosed is the Trustee’s notice to creditors pursuant to Section 102(1) of the BIA.

The Trustee notes that the assets of BR Partz and any distributions to secured creditors will be dealt with in the receivership proceedings (it is expected that there will be a shortfall to secured creditors and no funds available for unsecured creditors. As such, the Trustee advises creditors to review the materials filed on the GTL’s case website at:
